

In 2026, Investment Officer Belgium will host the **fifth edition of the Portfolio Day & Dinner**—a high-quality knowledge and networking event featuring a day and evening programme.

The day programme targets professionals in advisory roles at major banks, private banks, insurers, and independent wealth managers, with 75-100 expected guests.

We anticipate hosting approx. 25 guests at the (by-invitation-only) dinner (excluding partners).

The event and dinner will take place at AG Campus in the heart of Brussels (easily accessible by both public transport and car). It is AG Insurance's state-of-the-art learning and innovation centre.

Our host for the day will be Hanne Decoutere, VRT anchor. The day will be presented in English.

Investment Square

At Investment Square, attendees connect with leading experts from major investment firms partnering with the event. Experts engage in discussions with small groups of 8 to 10 attendees, sharing valuable knowledge and insights. Each session lasts 20 minutes and aims to establish meaningful connections that partners can follow up on after the event. There are a total of 4 sessions of 25 minutes each (including 5 minutes changing time), reaching approximately 32 – 40 contacts in two hours.




